WHEREAS, Article IV, Section 4.03, of the Architectural Covenants, Declaration of Easement, Covenants and Restrictions states that the architectural character of all structures, or alterations, additions, or improvements thereofwhen visually related to each other and the natural surrounding environment shall be, in the opinion of the review committee, harmonious in terms of the type size, scale, form, color and material; and

WHEREAS, Article V, Section 5.01, and 5.04 of the Architectural Covenants, Declaration of the Easement, Covenants and Restrictions provides the Review Committee the authority to adopt such rules, regulations, objectives, procedures, and guidelines as required by the Declaration and to establish standards for approval and disapproval; and

WHEREAS, there is a need to establish and modify rules and regulations concerning decks in the community and the Architectural Committee, in consultation with the Board of Directors, the following rules and regulations establish criteria for the approval of decks within Woods End Homeowners' Association.

NOW THEREFORE, **BE IT RESOLVED**, with the foregoing incorporated as if fully stated herein, the following was adopted after notice to the community and an open and duly caUed meeting of Woods End Homeowners Association, Inc.

Section C. DECKS

I.DECK DEFINITIONS

I.Must obtain permit and build in accordance with Prince George's County building code. Must first submit an application to the management company for review/approval by the ARC chair and Woods End Board prior to building a deck.

2.Use only pressure treated lumber - Resolution No. 2023-01 is now amended to allow staining decks. The colors listed below must not be altered. Two tone deck9 color gray stain with white railings and baluster/spindles stain are optional, otherwise the entire deck (post, ledgers,

deck boards, railings, and spindles) is to be stained all gray or all natural. Cannot mix gray and natural

7.Deck size is amended not to exceed 23' W X 15' Don end lots with den, and 18' W X 15' D on all other lots. Unfortunately, these deck sizes are for the homes that have the capacity. Any questions please contact the Arc Chair.

8. No stairs are permitted.

II .DECK DEFINITIONS

1. Additional Materials - COMPOSITE DECKING is now added material to Resolution 2022-03

Composite deck boards are denser, stronger, and heavier than wood alone. Composite Decking will not rot, warp, or splinter. Sustainably manufactured already pre colored and made in the USA. 2. Approved colors – Weathered Teak Timbertech-AZEK Vintage Collection (this composite decking color is comparable to the "natural stain" color for the wood decks).

Veranda Gray, Composite Decking; Manufactured by Fiberon (this composite decking color is comparable to the Driftwood or Cape Code gray stains for wood decks).

3. Deck railings and bahlster/spindles may be white, or the color of the composite decking mentioned above gray (Veranda) or natural (Weathered Teak). Armor Guard Classic 72 inches. White Composite. Stair Rail Kits manufactured by Fiberon.
